



Overview

The NMEA 2000[®] remote button is an external push button connected to the NMEA[®] backbone, used to mark a Crew Overboard waypoint at the vessel's location. If an emergency occurs, you can create a Crew Overboard waypoint with a short press of the NMEA 2000® remote button.


Create Crew Overboard waypoint

To create a Crew Overboard waypoint at the vessel's location, press the NMEA 2000® remote button once. When pressed, the LED light around the button starts flashing. Pressing the remote button repeatedly creates multiple waypoints.


Cancel Crew Overboard event

To cancel the last Crew Overboard event created, press and hold the NMEA 2000® remote button for three seconds. When the event is cancelled, the LED light around the button stops flashing. Alternatively, the event can be cancelled from the MFD or compatible instrument display (such as Triton²).






